THE CHALLENGE

The variety of cases the Ministère de l'Intérieur is responsible for investigating ranges from violent crimes such as homicide, to drug- and gang-related crimes, to property crimes and Internet crimes against children. Seventy-five percent of the evidence in these cases comes from smartphones, so it's often crucial for forensic examiners to be able to bypass password protection on encrypted devices, and to find and analyze relevant data from unsupported apps.

In addition, investigators need to be able to obtain cloud- or computerbased evidence from mobile synchronization when the device is unavailable or inaccessible. In these cases, the ability to combine computer, cloud, and mobile examinations into one case is important.

HOW AXIOM HELPS
